## **Terms and Conditions**

- a. The Ridge Street Carpark Resident Vehicle Permit only applies to the Ridge Street Carpark, where vehicles registered for a Resident Permit, can park for up to 90 minutes free of charge. It does not give any concession for on-street parking.
- b. The Ridge Street Resident Vehicle Permit is only available to residents of the North Sydney Council area.
- c. The costs are as follows:
  - Start up cost = \$35.00 (fee for one vehicle for one calendar year).
  - Ongoing cost = \$35.00 per calendar year per vehicle.
- d. A maximum of two Permits may be purchased for each residence in North Sydney. Proof of residential status must be provided.
- e. The Ridge Street carpark operates using Licence Plate Recognition (LPR) technology. It reads the registration plate of the vehicle on entry and exit, to determine the fees payable.
  - The Ridge Street Resident Permit system uses your vehicle licence plate number.
  - The vehicle licence plate number must be provided to Council's Customer Service staff on application or renewal of your permit. This will be entered into the Resident Permit system.
  - The Resident Permit system will automatically apply up to 90 minutes of free parking per day to vehicles registered in the system.
  - No passcard is required for this system.
- f. The Resident Vehicle Permit is available for use from the day of issue up to 31 May of the following calendar year.
- g. The Resident Vehicle Permit can be renewed upon payment of the recharge fee of \$35.00 at the Customer Service Centre, Council Chambers, 200 Miller Street, North Sydney.
- h. Failure to renew the permit will result in the normal fees for the Ridge Street carpark being applied for each visit, with no free parking period.
