RIDGE STREET CARPARK



Terms and Conditions

- a. The Ridge Street Carpark Resident Vehicle Permit only applies to the Ridge Street Carpark, where vehicles registered for a Resident Vehicle Permit, can park for a total of 90 minutes per day free of charge. Vehicles may enter the car park a maximum of two times per day but must not exceed a collective total time of 90 minutes parking. The Permit does not give any concession for onstreet parking.
- b. The Ridge Street Resident Vehicle Permit is only available to residents of the North Sydney Council area.
- c. The current rate for the Ridge Street Resident Vehicle Permit is as follows:
 - \$37.00 (for one year, starting from the date of purchase).
- d. A maximum of two Permits may be purchased for each residence in North Sydney Local Government area. Proof of residential status must be provided.
- e. The Ridge Street carpark operates using Licence Plate Recognition (LPR) technology. It reads the registration plate of the vehicle on entry and exit, to determine the fees payable.
 - The Ridge Street Resident Vehicle Permit system uses your vehicle licence plate number.
 - The vehicle licence plate number must be provided to Council's Customer Service staff on application or renewal of your permit. This will be entered into the Resident Vehicle Permit system.
 - The Resident Vehicle Permit system will automatically apply up to 90 minutes of free parking per day (inclusive) to vehicles registered in the system.
- f. The Resident Vehicle Permit can be used for one year from the date of issue.
- g. The Resident Vehicle Permit can be renewed by paying the recharge fee of \$37.00 at the Customer Service Centre, Council Chambers, 200 Miller Street, North Sydney.
- h. Failure to renew the permit will result in the normal fees for the Ridge Street carpark being applied for each visit, with no free parking period.
- i. Refunds will not be issued for vehicle registrations provided incorrectly or change of vehicle registration without prior notice given to Council.
- j. Vehicles registered for Resident Vehicle Permits are not eligible for other car park related discount schemes unless the vehicle registration is first removed from the account.
- k. North Sydney Council reserve the right to block or cancel permits if they are misused.
- North Sydney Council does not accept any responsibility for any loss or damage whatsoever to any motor vehicle or accessories or contents or other property or for the death or injury suffered to any person.
