All Certificates must include the following information: A limit of liability of at least \$20M. Amounts to be denominated in Australian dollars (AUD) in the first instance. Relevant jurisdiction to include the Australian Commonwealth. I understand that this insurance shall not be cancelled or lapse without the agreement of North Sydney Council and the policy document shall be endorsed to this effect.
