

## Summary of Actions Arising (SOA) Hayberry Precinct 2023

This document is North Sydney Council's response to actions arising from Precinct Committee Minutes. On receipt of the minutes, actions are numbered and allocated to relevant Council Officers for response.

To effectively manage and provide clarity, all actions are allocated a status when reporting to Precinct Committees in response to their minutes. There are three categories:

- **Awaiting Response** - action allotted to Council Officer - response awaited.
- **Open/Ongoing** - action allocated to Council Officer, initial response provided. Matter is ongoing and further response/update to be provided at a later date.
- **Closed for Council** - Council either completed related works/tasks or has taken all reasonable steps within its power to resolve issue (for example when a matter is beyond its jurisdiction). If the Precinct Committee feels Council can take further steps, they can request Council reopen action.

Research shows long closed streets are not conducive to encouraging foot traffic and create eventual physical isolation ultimately such a street closure will reduce customer traffic and encourage loitering. The issue raised was re the closure of Falcon Street to Alexander Street. DM advised this won't happen as it is a main artery for NSW Fire and Rescue Pumper 36 and others to and from Neutral Bay, Emergency Ambulances and Police. Expectation is Highway Patrol would object. Not only is it a critical access route to Neutral Bay to support Pumper 53 Yao Street and by return likewise but also when attending accidents on the Harbour Bridge. As the PP was not supported by Council and is the result of a successful rezoning review, the DPE are managing the plan making process (including exhibition and finalisation of PP). Submissions, including seeking an extension, should be directed to DPE.</p> <p>One of the key concerns raised in Council's assessment report related to the proposed supply of car parking and associated traffic generation. The reference scheme accompanying the PP responded to Council's maximum parking rates at the time. Council has since adopted an amendment to NSDCP 2013 which reduces on-site parking requirements for high density development in areas of high public transport accessibility. These reduced parking rates, which came into effect on 4 May 2023, apply to the Five Ways triangle site.
