

Summary of Actions Arising (SOA) Anzac Park 2024

This document is North Sydney Council's response to actions arising from Precinct Committee Minutes. On receipt of the minutes, actions are numbered and allocated to relevant Council Officers for response.

To effectively manage and provide clarity, all actions are allocated a status when reporting to Precinct Committees in response to their minutes. There are three categories:

- **Awaiting Response** - action allotted to Council Officer - response awaited.
- **Open/Ongoing** - action allocated to Council Officer, initial response provided. Matter ongoing and further response/update to be provided at later date.
- **Closed for Council** - Council either completed related works/tasks or has taken all reasonable steps within its power to resolve issue (for example when matter is beyond its jurisdiction). If the Precinct Committee feels Council can take further steps, they can request Council reopen action.

July		Council to please review & remove the offending two car spaces on West St near the Falcon Street Corner that impede traffic turning left or proceeding straight especially in Peak hours; and	<p>Council's Transport Engineer has responded that the specific location of the car spaces in question is not clear. However, it is important to note that Falcon Street is a key State Road and a crucial east-west link. Transport for NSW prioritises traffic flow on Falcon Street, which leads to longer green lights there and shorter ones on West Street, causing queues during peak hours.</p> <p>While improving vehicle throughput on West Street might seem beneficial, any changes that enhance capacity on this road, such as removing on-street parking, would primarily benefit traffic on Falcon Street. Unfortunately, this would likely result in minimal improvement for drivers on West Street.</p> <p>Council carefully evaluates the implications of such measures on local streets. Increasing traffic speeds at intersections, which can occur if parking spaces are removed, may negatively impact both safety and the local area's liveability. Moreover, residents on West Street have expressed concerns about the already limited availability of parking, and the removal of these spaces would further exacerbate this issue.</p> <p>Given these considerations, Council does not support the removal of the parking spaces at this time.</p>	Closed for Council

Council will also look to engage a consultant to understand what local options of stormwater management that can be implemented. The installation of new underground stormwater infrastructure is currently not a viable option as the underground infrastructure is not exclusively a North Sydney Council asset but also involves ownership by TfNSW and Sydney Water. They have young children and cannot risk their health and wellbeing now and in the future.</p> <p>We were informed by the residents that Council had identified the source of the problem in St Leonards Park years ago, and documented the remedial action required in Council's own Flood Management Plan - but no action was taken. Homes are now unliveable due to massive water ingress over hours cascading into their gardens and homes</p>	<p>Councils Service Unit Manager Capital Projects & Asset Management has advised Council understands the difficult circumstances that the residents are in with their properties being in an area that is formally identified as flood affected.</p> <p>Council has not identified St Leonards Park as the source of the problem but has aimed to illustrate the large catchment area that leads towards the low point near Lytton St of which St Leonards Parks contributes to. (presentation emailed to the Precinct on 31 July 2024)</p> <p>Council is seeking funding to undertake in-depth feasibility studies to consider possible options such as a retention bund wall in St Leonards Park. The construction of a retention basin requires design and modelling to understand its effectiveness and the impacts that this would have on the infrastructure in the park.</p>	Closed for Council
