


Minutes

5.2. Temporary Road Closure - Jacaranda Blooming Season - McDougall Street, Kirribilli

Report of Jasmine Wong, Traffic Engineer

This purpose of this report is to seek committee endorsement for temporary road closures in McDougall Street, Kirribilli during the annual Jacaranda blooming season.

- Each year between October and January, the Jacarandas that line both sides of McDougall Street in Kirribilli come into flower for a period of approximately 6 weeks.
- This seasonal occurrence which generally peaks in mid-November is a growing attraction for local North Sydney residents and tourists in recent years who wish to photograph themselves amongst the jacarandas which are flowering along the length of McDougall Street adjacent to Milson Park.
- The dates of the closures are dictated by the timing which the jacarandas bloom. The closures will be limited to six consecutive weekends from 26 October 2024 to 13 January 2025.
- This report has been prepared seeking endorsement for temporary road closures on McDougall Street and a section of Hipwood Street to manage the crowd for the 2024 jacaranda flowering season in McDougall Street, Kirribilli.

The cost of road closures identified for the six-week Jacaranda season will be covered by Council.

Recommending:

1. THAT the Committee endorse the temporary road closures in Kirribilli between the hours of 7am and 7pm on Saturdays and Sundays for six consecutive weekends between 26 October 2024 and 12 January 2025:

a. On McDougall Street, between Broughton Street and Willoughby Street; and

5.3. Temporary Road Closures - North Sydney Festival - Denison Street, Mount Street and Spring Street, North Sydney

Report of Pragya Sharma, Traffic and Transport Engineer, Traffic and Transport Operations The purpose of this report is to seek committee endorsement for temporary road closures to facilitate the North Sydney Festival, scheduled on Saturday, 2nd November 2024.

- North Sydney Council is proposing to host the North Sydney Festival, scheduled for Saturday, 2nd November 2024
- The event will be held on the streets of North Sydney CBD around Victoria Cross Metro and North Sydney stations
- Temporary road closures and traffic management measures are proposed to ensure the safety and smooth operation of the event. The event includes temporary road closures on Denison Street, Mount Street and Spring Street.

5.4. Temporary Road Closures - 2024 TCS Sydney Marathon - North Sydney

Report of Jasmine Wong, Transport Engineer

The purpose of this report is to seek committee endorsement for temporary road closures associated with the Sydney Marathon 2024, scheduled to be held on Sunday, 15 September 2024.

- Pont3 has applied for temporary road closures associated with the annual Tata Consultancy Services (TCS) Sydney Marathon event on 15 September 2024.

- The event is a Class 1 State Significant Event and is expected to attract over 40,000 participants across New South Wales, interstate and overseas. The running route showcases Sydney's historic landmarks including the Sydney Harbour Bridge and Opera House.
- Traffic changes related to the event, such as the temporary removal of on-street parking will commence at 8am Friday 13 September 2024, with road closures being undertaken between 3:30am Saturday 14 September 2024 to 12pm Sunday 15 September 2024.

All cost is required to be borne by the applicant.

5.5. Items Under Temporary Delegation to Council

Report of Pragya Sharma, Traffic and Transport Engineer, Traffic and Transport Operations To report to the Committee in regard to the items which are to be approved under temporary delegation to Council. Transport for NSW (Transport) has issued a temporary delegation of its powers under the Roads Act 1993, to give councils an alternative approval pathway (separate from the Local Traffic Committee process) for specified low-risk works to make streets more liveable, and support walking and cycling.

Attached is a list of projects given approval under the temporary delegation to Council. The temporary Delegation gives Councils an option to carry out works on unclassified roads without prior referral to the Local Traffic Committee, provided other conditions are met. The temporary Delegation is in place until 30 June 2026 unless revoked prior to this date. The cost for these projects is proposed to be funded from Traffic's LATM budget and Council's 2024/25 operational budget.
