

PURPOSE:

The purpose of this report is to seek committee endorsement for the installation of 15-minute parking restriction in Alexander Street, Crows Nest.

EXECUTIVE SUMMARY:

- Council has received concerns about limited parking availability on Alexander Street in Crows Nest for Mobility Parking Scheme permit holders accessing the shops in the area.
- On street dedicated disability parking spaces in commercial areas tends to result in a single vehicle parked all day and provides limited improvement to accessibility. For this reason, Council does not support dedicated disability parking spaces in commercial areas.
- In response to the concerns raised, Council is planning to install two (2) "No Stopping 6:30am-9:30am 3:30pm-6:30pm Mon-Fri" and "1/4P 9:30am-3:30pm Mon-Fri, 8:30am-12:30pm Sat" spaces.

RECOMMENDATION:

1. THAT the Committee endorse the reallocation of kerb space on the eastern side of Alexander Street, Crows Nest between points 29 metres and 41 metres (2 car spaces), south of Burlington Street as "No Stopping 6:30am-9:30am & 3:30pm-6:30pm Mon-Fri" and "1/4P 9:30am-3:30pm Mon-Fri, 8:30am-12:30pm Sat".

Background

In response to concerns about limited parking availability on Alexander Street, Council is considering a proposal to introduce two (2) 15-minute parking spaces to improve turnover and accessibility for short-term visitors. This initiative aims to address the needs of customers making quick stops for shopping, takeaways, or other brief errands while maintaining sufficient parking options for longer stays elsewhere in the area while also encouraging the availability of parking for drivers with Mobility Permit Scheme permits.

Report

Alexander Street and the surrounding streets generally has 1-hour parking restrictions, with some areas allowing 2-hour parking to accommodate business and visitor needs. The proposal seeks to introduce two (2) 15-minute parking spaces to address concerns about short-term parking availability without significantly reducing longer-term parking options.

The proposal incorporates the following adjustments:

Current parking restrictions:

- "2P Meter, 9:30am-3:30pm Mon-Fri, 8:30am-12:30pm Sat, Permit Holders Excepted Area 19"
- "No Stopping, 6:30am-9:30am & 3:30pm-6:30pm Mon-Fri"

Proposed changes:

- "1/4P, 9:30am-3:30pm Mon-Fri, 8:30am-12:30pm Sat"
- "No Stopping, 6:30am-9:30am & 3:30pm-6:30pm Mon-Fri"

By removing the metered parking requirement and Permit Holders Excepted Area 19 restrictions, the proposal aims to increase turnover and availability for short-term parking. This would particularly benefit businesses that rely on quick customer visits, such as cafes, convenience stores, and retail shops. Customers needing brief stops, pickups, or drop-offs would have improved access to parking, reducing circulation and congestion caused by drivers searching for short-term spaces.

Additionally, mobility parking permit holders would be allowed to use these spaces for up to 30 minutes, ensuring accessibility for people with disabilities.

Consultation requirements

Community engagement has occurred in accordance with Council's Community Engagement Protocol. The detail of this report provides the outcomes from the engagement for Council to consider prior to adoption.

Public Consultation

Community consultation on this proposal took place from 15th November 2024 to 11th February 2025. Approximately 136 letters were delivered to the households and businesses in the surrounding area and the survey was available online through Council's 'Have Your Say' webpage. A total of 4 responses were received including 3 responses from outside the survey area.

The results indicated 75% support and 25% opposition for the proposal. The results of the survey are shown in table below:

Non-private Transport Mode	Provide more benefits to non-private vehicle owners, should reduce the amount of on street parking and decrease the speed limit	Council prioritises sustainable transport and is committed to reducing reliance on private vehicles. Our Integrated Transport Strategy promotes walking, cycling, and public transport use. To support this, we recently installed a bus stop on Alexander Street and are exploring ways to reduce on-street parking to enhance active and public transport infrastructure.

Short-term Access to Local Business	I fully support changes to parking intended to facilitate short-term access to local businesses.	Council supports lower speed limits to improve safety, the decision on posted speed limits is determined by Transport for NSW (TfNSW). Noted.
Limits Ability for Shopping	People using Alexander St use it to do business which requires more than 15 min. Having a 15 min time limit removes the ability to do shopping or have a coffee or meet and conduct business. There is no logical reason to reduce the time, and it WILL NOT benefit the businesses.	Most of Alexander Street and the surrounding streets already have 1-hour parking restrictions, with some areas allowing 2-hour parking to accommodate business and visitor needs. The proposal includes only two spaces with a 15-minute limit, aimed at increasing turnover and availability for short-term parking. This benefits local business and customers needing brief stops, and pickups or drop-offs, without significantly reducing longer-term parking options in the area.

Financial/Resource Implications

The cost of undertaking proposed changes to parking restrictions will be covered by Council's Operational Expenditure budget for signage.
