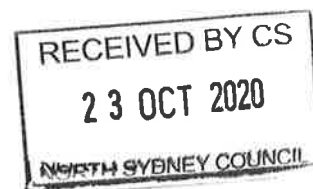


# HOLTERMANN PRECINCT

## Minutes Wednesday 16 September 2020

These are the recorded Minutes of the Holtermann Precinct Meeting held on Wednesday 16 September 2020 at the Crows Nest Centre. The Meeting was held under COVID conditions, with social distancing and the provision of Hand sanitizer, antibacterial wipes and gloves.
