#### **PURPOSE:**

# Background

The Charter of the Sustainable Transport Reference Group states:

10.4 A report on the proceedings of Reference Group meetings are to be submitted to the next available meeting of Council for endorsement, including all recommendations. Any Councillor, irrespective of whether that Councillor is a member that Reference Group, may be the mover or seconder of a motion to confirm the proceedings of a Reference Group meeting.

## Report

Section 7.2 of the Reference Group Charter states that:

The Reference Group does not have the power to bind the Council.

This report presents the recommendations of the last meeting of the Sustainable Transport Reference Group held on 16 May 2023.

The Reference Group recommendations for action to Council are considered below.

## 1.1 General Business - trial of 30kph speed limits

The Reference Group made the following recommendation:

**1. THAT** Council investigate a trial of 30kph speed limits focusing on school routes being West Street where the stage 2 cycleway will be once finished as well as Broughton Street from McDougall Street, and to rapidly expand 30kph zones to cover all residential streets.

While Council supports the implementation of 30km/h on local streets where possible, Council is currently attempting to get 40km/hrs accepted by TfNSW, which tends to require significant infrastructure.

It is therefore proposed that the recommendations for General Business Item 1.1 not be adopted.

## 2.1 General Business - Slow down Traffic around school – Centre Line

The Reference Group made the following recommendation:

**1. THAT** the Committee request that Transport for NSW review the streets in which schools are situated which have a broken centre line and that the highest speed limits on the school streets are 40kph – 50kph.

At the meeting, the Manager Traffic & Transport Operations noted prior to the resolution being passed at the meeting, that it will channelise traffic and potentially increase vehicle speeds.

It is therefore proposed that the recommendations for General Business Item 2.1 not be adopted.

## 3.General Business - Improving Walking Facilities for Kids going to and from school

## **1. THAT** Council consider making intersections at right angles.

With respect to General Business Item 3, Council's Traffic Engineers currently do consider making any intersection under review at right angles as the first option.

This recommendation of the Reference Group is supported, amended as follows as a recommendation to Council:

**1. THAT** Council note that it is currently the practice to make any intersection at right angles when proposing changes to the design of any intersection.
