

# **Ausgrid's Community Battery Trial**







- Ausgrid's Community Battery trial is a flagship project within our Network Innovation Program and was co-designed with the Network Innovation Advisory Committee (NIAC).
- The trial was set up to test how three benefit streams could be unlocked in one shared battery:
  - Customer storage as a service
  - Strengthening the local network
  - · Supporting wider system stability
- The trial started in 2021 and is due to wrap up towards the end of 2023.
- Over this time, significant support has been building for local energy solutions amongst customers, communities and government.



# Ausgrid 2024-29 Reg Reset Customer Engagement

#### What customers have told us on community batteries

Customers valued Ausgrid delivering community batteries because they support wider renewable energy development and replaced investment in traditional network solutions.

#### Our customers told us:

'Supports the drive to net zero carbon'

'More the merrier'

'If we are moving to net zero, we need to start here'

'Good to see you are working on this'

'Look back 20 years ago with how solar panels were and look at now with where they are. The technology has gotten better, cheaper, and more reliable. Community batteries are new like solar was decades ago'

'Suggestion to prioritise community batteries in areas with high density, heritage limitations, lots of renters, ... so that they can benefit from renewables and reduced cost.'



# Key learnings from our community battery trial

- **Community engagement:** proactive upfront engagement with councils and communities and considering their feedback in our design is key.
- **Safety and clearance**: batteries must be accessible and have a certain clearance zone around the immediate vicinity of the battery.
- **Road traffic:** where possible, our preference is to locate the battery in low-traffic zones or install barriers to minimise risks of vehicle collisions. We also take care to ensure the battery does not obscure vehicular traffic view.
- **Noise:** we maintain ambient battery noise levels below the thresholds set by the Environmental Protection Agency.
- Environmental and heritage considerations: we prefer to minimise vegetation clearance, consider water ingress risks and assess sites for potential cultural or heritage significance.
- **Network configuration:** where possible, minimal upgrades to the network to connect the battery are preferred. The intention is to install batteries to mitigate the need for traditional network augmentation.
- Network support: given the above considerations are met, we select locations where batteries provide maximum network support selecting initial regions for assessment based on likely network benefits (e.g. where the battery can avoid or delay future network upgrades) helps to optimise this.
- **Storage as a service:** this is not a scalable model yet due to current market settlement processes and regulatory arrangements.

Our ambition is to continue to use the pilot period to explore viability of alternative commercial models that could unlock further value and enable customer storage service at scale.

# Federal Government's Community Batteries for Household Solar Grants

- The Federal Government has committed \$224.3 million to help install up to 400 Community Batteries across the country.
- The Department of Climate Change, Energy, Environment and Water (DCCEEW) released the initial funding streams:
  - Stream 1 (56 eligible locations) and Stream 2 (2 eligible locations), submissions opened 31 January 2023 and closed 24 February 2023.
    - Grant applications submitted 24 February 2023.
    - We applied for the six eligible locations within Ausgrid's footprint Bondi/Bondi Beach, Breakfast Point/Cabarita, Cammeray, Narara, Warriewood, North Epping.
    - We are testing our proposed battery locations with the community before committing to a site.
- Final streams will administered by Australian Renewable Energy Agency (ARENA).

# Why was Green Park proposed?

Green Park met all technical aspects for hosting a community battery including:

- Community
  - provide support to around 250 local households.
  - currently approx. 8% solar penetration, high potential for solar growth in area.
  - high potential growth for electric vehicle charging.
- Environmental
  - low risk of vehicle collisions and does not obscure driver visibility.
  - no tree trimming or removal.
  - low risk of flooding.
- Network
  - can connect into existing network with minimal upgrade and trenching.
  - the battery can avoid or delay future network upgrades.







# Alternative sites considered not feasible

# Site 1 – Park Ave & Grasmere Rd

- Underground services.
- Obscures driver visibility.

# Site 2 – Cammeray & Warringa Rds

• Flood basin / high risk of flooding.

# Site 3 – Primrose Park

- No suitable area within the eligible boundaries.
- No road access.
