# **10.1. 2024** Australian Local Government Association Annual Conference (National General Assembly)

#### **AUTHOR:** Ian Curry, Manager Governance

#### PURPOSE

The purpose of this report is to consider the appointment of delegates for attendance at the 2024 National General Assembly, and any proposed Motions.

#### **EXECUTIVE SUMMARY**

- The 2024 Australian Local Government Association (ALGA) National General Assembly (NGA) will be held in Canberra, from 2 to 4 July 2024.
- The theme for this year's NGA will be "Building Community Trust." ALGA is seeking motions that align with this theme, and which identify opportunities for new federal programs and policies that will support councils to build stronger communities. Motions are due by 30 April 2024.
- In addition, Council may resolve the appointment of delegates to attend the 2024 NGA. The early bird deadline for registrations is 7 June 2024.

This matter was previously considered by Council at its meeting on 26 February 2024.

#### Loss of Tree Canopy

**I(a). THAT** the ALGA resolves to lobby the Federal Government to financially support Local Government programs and initiatives which seeks to address the ongoing loss of tree canopy across Australia.

#### <u>Background</u>

Many Councils across Australia are already designing and implementing innovative ways to increase tree canopy much of which is as a result of state government projects or private development. These projects come at a cost to councils and would be able to be more widely delivered and more accessible if federal funding for this purpose was made available to local government.

North Sydney Council has received positive and appreciative feedback from residents and members of the community for the "trees for newborns" and Streets Alive programs which contribute to Council aim to increase total canopy cover to 34.4%. Since 2008, canopy cover has declined by 11.7% in the North Sydney local government area. These initiatives seek to involve the community in ongoing efforts to increase tree canopy, as well as celebrating the arrival of a new resident and encouraging members of the community to be actively involved in their local environment.

# **Housing Affordability Crisis**

**II(a). THAT** this conference recognises that the housing affordability crisis across Australia requires a multifaceted and nuanced approach from all levels of government.

**II(b). THAT** the ALGA lobby the Federal Government to work directly with Local Government to provide funding directly to councils to support the local delivery of social and affordable housing.

THAT** the ALGA write to the Federal Minister for Local Government asking that federal funding provided to the States be linked to the delivery of social and affordable housing in state owned projects and that the commitment to the provision of social and affordable housing be in in perpetuity, not on a short term basis.

Rather than rates increasing with population, the same rates are just shared among more ratepayers who live on the same size land which does not increase rate revenue.

In regional and rural councils, there are not sufficient rateable properties to sustain the council services and infrastructure such as roads, waste, and public infrastructure. And in councils with tourist centres, again there are not sufficient rateable properties to support the cost of providing appropriate and necessary tourism infrastructure such as public amenities, roads, open space, footpaths, and cycleways.

Consideration also needs to be given to non-rateable properties such as schools, religious bodies etc who use Council's services such as parks, footpaths, community centres, and the like but pay no contribution. In urban areas, rateable properties are often purchased by institutions which are exempt from paying rates resulting in a previously rateable property converting to non-rateable due to its change of use.

# **10.2.** Investment and Loan Borrowings Report as at 31 March 2024

# PURPOSE

The purpose of this report is to provide details of the performance of Council's investments and loans for the month ending 31 March 2024.

#### **EXECUTIVE SUMMARY**

- All investments have been made in accordance with the Local Government Act and Regulations and Council's Financial Investments Policy.
- For the month of March, the total investment portfolio (Term Deposits, Floating Rate Notes and Bonds) provided a return of +0.31% (actual), or +3.70% p.a. (annualised), marginally under-performing the benchmark AusBond Bank Bill Index return of +0.37% (actual), or +4.41% p.a. (annualised). This is due to Council holding term deposits made in a low inflation environment when interest rate rises were not expected.
- Returns on investments exceed the YTD budget by \$885.55 thousand. The total return for the 2023/2024 financial year to date is approximately \$4.18 million. The better-thanexpected return is due to payments for the capital works program progressing slower than expected in the first two quarters. The budget will be reviewed in the March Quarterly Budget Review.

#### PURPOSE

The purpose of this report is to inform Council:

#### **EXECUTIVE SUMMARY**

- The NSW Government has withdrawn the review of the financial model of local government in NSW by the Independent Pricing and Regulatory Tribunal (IPART), with the announcement the matter will now instead be considered by the NSW Parliament's Standing Committee on State Development.
- There is a previous Council submission on the Terms of Reference for the IPART review, as endorsed by Council in their meeting of 11 March 2024. IPART has advised all previous submissions will be provided to the NSW Standing Committee on State Development to inform their review.
- A further review of local government financial sustainability has been announced by the Federal Government House of Representatives Standing Committee on Regional Development, Infrastructure, and Transport. - In October 2023, the Minister for Planning wrote to all Councils in NSW requesting that planning controls be urgently reviewed to address the housing crisis in NSW.
- In response, Council considered a Mayoral Minute at its meeting on 27 November 2023, which included a request that:

Council undertake an urgent review of DA (development applications) assessment/determination times with reference to the model put forward by

Newcastle City Council at the recent Local Government Conference and collaborate with other councils to adopt best practice.

- This report describes the Newcastle City Council model of development assessment in response to that resolution and provides an analysis of whether such model may be workable and successful in North Sydney.
- It also outlines what progress Council staff have made and are continuing to invest in, to achieve improved determination times and customer service in North Sydney.

# 10.5. Community Centres - Joint Strategic Plans review 2022/2023

AUTHOR: Kate Stewart, Manager Library Services

#### PURPOSE

The purpose of this report is to present to Council the 2022/2023 review of Council's Joint Strategic Plans with each of the North Sydney Community Centres:

#### EXECUTIVE SUMMARY

- The four community centres in the North Sydney Local Government Area operate as independent not-for-profits out of Council-owned properties. Council provides annual operational grants to each centre, as well as providing subsidies for rates, waste, and property maintenance.

- Each centre has a Joint Strategic Plan, a joint planning statement with Council based on the Centre's strategic plan, and Council's Community, Cultural, and Recreational Facilities Policy. The joint strategic plan for each community centre is reviewed annually and referred to Council.

#### EXECUTIVE SUMMARY

- The project has been delayed due to ongoing issues associated with the structural steel roof over the 25-metre pool. Practical Completion is anticipated late 2024/early 2025 as previously reported to Council.
- Council's project team has addressed over 1,200 Requests for Information and have now assessed 371 Variations and 145 Extensions of time associated with the design and construction of the project.

- The current construction contract value is \$88.12M as of 13 March 2024, however Council continues to receive variations associated with latent conditions, along with design and construction-related issues.
