#### **PURPOSE:**

The purpose of this report is to advise Council of the outcome of the recent tender (1/2024) for Civil works contractors to form a panel for civil works based on an adopted schedule of rates.

#### **EXECUTIVE SUMMARY:**

- The current panel used for Council's civil works contractors has now expired and Council required to publicly request tenders for contractors interested in undertaking civil work for Council.
- In June 2024, council sought tenders from appropriately qualified contractor to for a new Schedule of Rates panel (Contract 1/2024) for civil works.
- 34 Submissions were received when the tender closed on 3 July 2024.
- Submissions were subsequently assessed for conformity against the identified criteria and a shortlisted panel of contractors has now been identified.

#### **RECOMMENDATION:**

- **1. THAT** Council accept the short-list of tenderers as outlined in Attachment 1 this report for Tender 1/2024 Schedule of Rates Contract for Civil Works.
- **2. THAT** the Chief Executive Officer be authorised to take any necessary action to implement the decision including entering into associated contracts.
- **3. THAT** the Chief Executive Officer is the delegated Authority to negotiate a variance in the annual adjustment of the rates due to unforeseen circumstances that may arise.
- **4. THAT** the Director of Open space and Infrastructure is the delegated Authority to extend the contract options as per clauses in the tender documents.

### Background

Clause 169 of the Local Government Regulation allows a Council to establish a list of contractors for proposed works of a specified kind.

Since 1993, North Sydney Council has used this form of procurement to establish a panel of contractors under a schedule of rates contract for civil works. The establishment of this type of panel through a tender ensures competitive pricing, fixes prices for the period of the contract (subject to CPI), improves the efficiency of procurement, and provides an opportunity for appropriately qualified contractors to work for Council.

Over 800 projects have been completed with a total value of \$39.3m under the current contract. Without a panel, all 800 projects would have required individual tender processes.

The current panel used for these works has now expired and Council is required to publicly request tenders for contractors interested in undertaking civil work for Council.

It should be noted that contractors on panels are still required to submit formal quotations.

In June 2024, tenders were subsequently invited from appropriately qualified contractors to submit schedules of rates for Civil works (tender #1/2024) for the next three years. The contract also includes two additional one-year extensions, which are at the discretion of Council. A CPI rate increase of 3% for each year after the first 12 months of the contract's operation is allowed for, to factor in inflation and building escalation costs.

Tenderers were required to submit rates on either selected works, or all works as listed in the following categories:

#### PART 1 - CIVIL WORKS

- Stormwater Drainage
- Road Reconstruction Asphalt & Concrete
- Kerb & Gutter
- Footpaths
- Stairway Construction

#### PART 2 - LINEMARKING & SIGN POSTING

#### PART 3 - FURNITURE & FENCES

- Timber Seats & Tables
- Timber Ordinance Fencing
- Street Furniture

## PART 4 - RETENTION AND ROAD BARRIERS

- Reinforced Soil Retaining Wall (Medium to High Walls)
- Sandstone Block Retaining Wall (Low Height Walls)
- RC Blockwork Retaining Wall (Medium Height Walls)
- Rock Face Stabilisation
- Wire Rope Barrier (Non-Rigid)
- Steel Rail Barrier (Rigid)

### PART 5 - MINOR REPAIRS & RESTORATIONS

## **Tender Analysis**

Submissions were subsequently assessed in accordance with the Local Government Act 1993 and the Local Government (General) Regulation 2005, using the following selection criteria as outlined within the tender documents:

- submitted schedule of rates;
- demonstrated capacity, experience and technical ability to carry out the work specified.
   Specifically, past experience undertaking similar projects, experience of staff, and availability of required equipment;
- demonstrated commitment to sustainability principles in the Sustainability Statement provided within the tender documentation;
- demonstrated capacity to fulfil Work, Health, and Safety, and environmental requirements in accordance with Council's specified standards, policies, and current legislation;
- current insurance policies in accordance with Council's Procurement Policy.

The assessments panel comprised of staff from across Council, including Council's Senior Sustainability Programs Co-Ordinator

Based on the abovementioned criteria, it is recommended that the tenderers listed in Attachment 1 to this report be shortlisted on the Panel for the identified work categories.

## **Consultation requirements**

Community engagement is not required.

# **Financial/Resource Implications**

The creation of panels enables Council to ensure best value for money through an open tender and fixing of prices (subject to CPI increase) for a fixed term.

# Legislation

The proposal to create a panel for civil works projects is consistent with the s55 of the NSW Local Government Act 1993 and s179 of the NSW Local Government Regulation.
