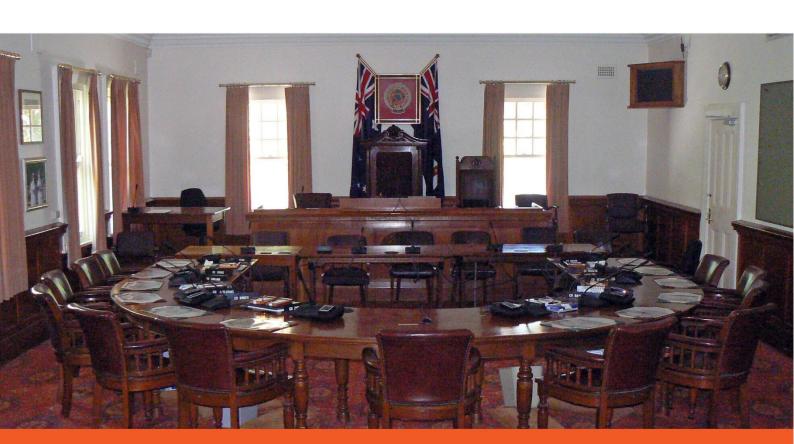

8. Mayoral Minutes

8.1. MM01: Farewell Councillor Jilly Gibson, Councillor Georgia Lamb, and Councillor John Lepouris

On 14 September 2024, local government elections will be held across New South Wales. On 14 August 2024, when nominations closed, current serving councillors Councillor Jilly Gibson, Councillor Georgia Lamb, and Councillor John Lepouris had not nominated for re-election.

Councillor Jilly Gibson has served on Council for more than 25 years. Councillor Gibson was first elected in 1999 representing Tunks Ward and subsequently represented Victoria Ward (now Cammeraygal) from 2004 - present.

In 2012 Councillor Gibson was directly elected Mayor of North Sydney and served in that role until 2021. Throughout her service on Council, Councillor Gibson has exhibited an abiding interest in arts and culture and particular passion for Kirribilli, Lavender Bay, and McMahons Point. Councillor Gibson has given long service to our community.

Councillor Georgia Lamb was elected representing Cammeraygal Ward in 2021 at the age of 20 years. The youngest councillor to serve, she brought a unique perspective and a focus on sustainability to her role.

Councillor John Lepouris is the first councillor to assume the role by way of the recently introduced "countback" provisions, joining Council at the meeting held on 27 February 2023 following the resignation of Councillor Alanya Drummond in January 2023. Councillor Lepouris represents St Leonards Ward and brought his passion for Neutral Bay and the needs of small business to his role.

Serving as a councillor requires significant commitment and time. Such service is not possible without the support and understanding of the representative's family, friends, and colleagues.

PURPOSE

The purpose of this report is to provide details of the performance of Council's investments and loans for the month ending 31 July 2024.

EXECUTIVE SUMMARY

- All investments have been made in accordance with the Local Government Act and Regulations and Council's Financial Investments Policy.
- For the month of July, the total investment portfolio (Term Deposits, Floating Rate Notes and Bonds) provided a return of +0.28% (actual), or +3.32% p.a. (annualised), underperforming the benchmark AusBond Bank Bill Index return of +0.37% (actual), or +4.49% p.a. (annualised). This is due to Council holding term deposits made in a low inflation environment when interest rate rises were not expected, and a higher than usual percentage of investments held as cash to pay for expected project costs.
- Returns on investments exceed the YTD budget by \$209,000.

10.4. NSW Government's Crows Nest Transport Oriented Development rezoning proposal

PURPOSE

The purpose of this report is to make a submission to the Department of Planning, Housing, and Infrastructure on the Crows Nest Transport Oriented Development (TOD) rezoning proposal that is being exhibited for public comment between 16 July – 30 August 2024.

EXECUTIVE SUMMARY

- On 7 December 2023, the NSW Government announced the TOD Program. The program aims to increase housing supply close to public transport, jobs, and services in Metropolitan Sydney, and extending to Wollongong and Newcastle. Crows Nest and surrounds was identified as one of eight 'TOD Tier 1 precincts' for accelerated, state-led rezoning under the program. It forms part of a much larger tranche of state planning reforms which aim to increase residential densities in the region, fast track development assessment, and deliver more affordable housing.
- On 16 July 2024, the Department of Planning, Housing, and Infrastructure ('the Department') released the Crows Nest TOD rezoning proposal for public comment. It enables the delivery of 3,255 new dwellings and 2,600 new jobs in the precinct. Taking into account the Department's previous St Leonards Crows Nest Planning Study (2020) (the '2036 Plan'), the precinct is now set to grow by 8,445 new dwellings, representing 16,000 new residents.
- The Crows Nest TOD rezoning proposal, as outlined in the Explanation of Intended Effects:
 - further increases the maximum tower heights and residential densities above the 2036 Plan;
 - converts some planned employment capacity to additional residential capacity;
 - introduces a mandatory affordable housing contribution of 10-15% on all new residential development, to be held in perpetuity;
 - introduces additional affordable housing 'bonus provisions' to allow conversion of the planned commercial Crows Nest Metro 'Site A' to a residential tower, and greater height on four sites directly opposite the metro station;
 - introduces a provision that requires the consent authority to consider a new Design Guide that prevails over the *North Sydney Development Control Plan* (2013);
 - indicates a potential future open space at 79-81 Sinclair Street could be achieved via an additional height and floor space uplift; and
 - rezones land along Sinclair Street, not previously included in the 2036 Plan.
- The draft Design Guide, also on exhibition, introduces a new vision and set of principles and objectives for the precinct. It also introduces design guidance covering Connecting

with Country, built form design, design excellence, environment, and movement. Car parking rates are proposed to remain unchanged.

- The NSW Government announced \$520 million from the Housing and Productivity Contribution Fund will be shared across the eight TOD Tier 1 precincts for state infrastructure. Increased demand for local infrastructure is to continue to be levied for under the North Sydney Local Infrastructure Contributions Plan (2020).
- Overall, the Crows Nest rezoning package has the potential to deliver some high-quality mixed-use towers and deliver greater housing supply, including affordable housing, and local services close to exceptional public transport and health infrastructure. Amendments to the proposal are needed, however, to protect sunlight to Willoughby Road, Ernest Place, Wollstonecraft and surrounds, and improve built form design.
- Concern is raised at the extensive, rapid rezoning of the precinct for predominantly residential purposes, and continued application of the NSW Government's built-to-rent provisions in commercial centres. Council estimates this translates to a potential loss of up to 11,000 planned jobs capacity over the long term, significantly compromising the strategic economic function of the centre.
- Similarly, concern is raised at the lack of open space, recreation, cultural, and social
 infrastructure plans to support the estimated 16,000 new residents in the precinct. A
 funding mechanism to deliver Hume Street Park upgrades needs to be identified
 immediately.
- Given the limited timeframe to review and report this matter, the rezoning proposal has not been reviewed to the level of detail that would normally be undertaken for a project of this scale and complexity. Accordingly, the submission focusses on key issues and raises detailed comments, where possible.
- This report outlines key elements of the proposal, discusses key matters for consideration, and recommends Council endorse a submission to the Department on the Crows Nest TOD rezoning proposal. At the time of completion of this report, the detailed submission, which is summarised in this report, was yet to be finalised. The detailed submission for Council's consideration will be published and form part of Council's business paper by Tuesday 20 August 2024.

PURPOSE:

The purpose of this report is for Council to consider a submission drafted in response to the Western Harbour Tunnel (WHT) Place Design and Landscape Plan (PDLP).

- Consultation for the Place, Design and Landscape Plan (PDLP) for the Western Harbour Tunnel (WHT) commenced on the 31 July 2024 and closes on 28 August 2024.

- Council officers have developed a submission in response to the PDLP, which is attached herein.
- The submission includes requests and feedback previously provided to the NSW State Government in relation to this project and representations that have been made to Council by the community of North Sydney.

Background

On 31 July 2024, TfNSW opened consultation on the Place, Design and Landscape Plan for the Western Harbour Tunnel, seeking feedback on following aspects of the project:

- ventilation facilities
- tunnel portals (entry and exits)
- landscape design
- tunnel interiors

Public Consultation will close on 28 August 2024.
