10.1. Election of Mayor

Report of Ian Curry, Manager Governance

The purpose of this report is to facilitate the election of the Mayor for the period 8 October 2024 to 30 September 2026, in accordance with section 230 of the Local Government Act NSW 1993 (the Act).

- The term for the position of the Mayor elected by Councillors is two years (October 2024- September 2026).
- The returning officer is to be the Chief Executive Officer, or a person appointed by the Chief Executive Officer.
- Nominations must be in writing, in accordance with clause 2 of Schedule 7 of the Local

Government (General) Regulation 2005 (The Schedule), a copy of which is attached.

- Nominations must be provided to the Chief Executive Officer (via Governance, or directly) prior to the commencement of the election. Councillors are encouraged to submit nominations in advance to ensure their validity is confirmed prior to the election. Schedule 7 governs the election of a Mayor or Deputy Mayor by councillors.

RECOMMENDATION:

- **1. THAT** an election be held to elect a Mayor for the period 8 October 2024 to 30 September 2026.
- 2. THAT Council determine the method of voting.

3. THAT the Coordinator General, Planning Delivery and Local Government and the Secretary and Chief Executive Officer of Local Government New South Wales be advised of the election result.

10.2. Election of Deputy Mayor

The purpose of this report is to facilitate an election for the position of Deputy Mayor, in accordance with Council's Deputy Mayor Policy. In accordance with the Local Government (General) Regulation 2005, the Chief Executive Officer is the Returning Officer.

- Council's Deputy Mayor Policy and Section 231 of the Local Government Act 1993 states that Council may elect a Deputy Mayor. The Policy provides that the Deputy Mayor will be appointed for a period from 1 October to 30 September. However, the legislation provides that the Deputy Mayor may be elected for the Mayoral term, or a shorter term.
- Nominations must be in writing, in accordance with clause 2 of Schedule 7 of the Local

Government (General) Regulation 2005 (The Schedule), a copy of which is attached to the previous report.

- Nominations must be provided to the Chief Executive Officer (via Governance, or directly) prior to the commencement of the election. Councillors are encouraged to submit nominations in advance to ensure their validity is confirmed prior to the election. Schedule 7 governs the election of a Mayor, or Deputy Mayor, by councillors.

RECOMMENDATION:

- **1. THAT** Council resolve to appoint a Councillor to be the Deputy Mayor in accordance with section 231(1) of the Local Government Act 1993.
- **2. THAT** an election be held to elect a Deputy Mayor for the period 8 October 2024 to 30 September 2025.
- **3. THAT** Council determine the method of voting as open voting in accordance with Council's Deputy Mayor Policy.
- **4. THAT** the Coordinator General, Planning Delivery and Local Government and the Secretary and Chief Executive Officer of Local Government New South Wales be advised of the election result.

10.3. Using Countbacks to fill Casual Vacancies

To propose that Council exercise the option of using a countback of votes cast at the last ordinary election to fill casual vacancies occurring in the offices of Councillors in the first 18 months after the election.

- Following the December 2021 Local Government Elections, for the first time Councils had the option of using a countback of votes cast at the ordinary election to fill casual vacancies occurring in the offices of Councillors in the first 18 months after the election.
- This will allow Councils to use a countback to fill vacancies at a lower cost than the cost of holding a by-election.

- If Council does not resolve to take advantage of this provision at the first meeting after the election, it will be required to fill any casual vacancy through a by-election.
- The Office of Local Government (OLG) has provided wording for a recommendation should Council wish to exercise this option.

RECOMMENDATION:

1. THAT Council, pursuant to section 291A(1)(b) of the Local Government Act 1993, declare that casual vacancies occurring in the office of a Councillor within 18 months after the last ordinary election of Councillors for the Council on 14 September 2024, are to be filled by a countback of votes cast at that election for the office in accordance with section 291A of the Act and directs the Chief Executive Officer to notify the Electoral Commissioner for NSW of Council's decision within 7 days of this decision.

10.4. Council Meeting Schedule 2024/25

The purpose of this report is to determine a schedule of Council Meeting dates for 2024/24.

- The Local Government Act prescribes that Councils are required to meet at least 10 times each year, each time in a different month.
- In June 2022, Council adopted a fortnightly schedule for Council meetings.
- This report proposes a schedule of Council meetings to September 2025 and a change of start time to 7.00pm.

RECOMMENDATION:

- **1. THAT** Council adopts the attached Council Meeting schedule for 2024/25 and note the change of start time from 6.30pm to 7.00pm.
- **2. THAT** Council notes the attached planned Agenda publication dates for Council Meetings in 2024/25.

10.5. 2024 Local Government NSW Annual Conference - Delegates and Motions

The purpose of this report is to outline the process for submitting Motions for consideration at the Local Government NSW (LGNSW) Annual Conference.

- The Local Government NSW (LGNSW) Annual Conference is taking place from 17 to 19 November 2024, at Tamworth Regional Entertainment and Conference Centre, and will feature a range of keynote speakers, workshops, training sessions, and more.
- As the main policy-making event for the NSW local government sector, the Annual Conference is an opportunity to help set the advocacy agenda for the year ahead. Motions passed at the Conference become Resolutions, which LGNSW actions on behalf of its members, as part of its advocacy program.
- This is the follow-up to a report submitted to Council in June 2024

RECOMMENDATION:

1.THAT Council nominates five voting delegates for the 2024 LGNSW Conference at Tamworth Regional Entertainment and Conference Centre.

- **2.THAT** other councillors interested in attending the conference as non-voting delegates advise the Chief Executive Officer as soon as practicable, noting that no further registrations will be made following Monday 14 October 2024.
- **3. THAT** Councillors submit suggested issues for Council's consideration as Motions to the LGNSW Annual Conference.

10.6. Appointment of Council representatives on Council committees and external bodies
