## GF01: Investments and Loan Borrowings Held as at 31 August 2019

Report of Garry Ross, Manager Financial Services

Investment Advisory Services were recently tendered and Imperium Markets have been appointed for the 3-year term. This report has been prepared with their assistance and representatives of Imperium have been invited to give a brief presentation to outline their proposed investment strategy for North Sydney Council. Councillors will have an opportunity to address any concerns or issues associated with the current Investment portfolio and be involved in the review of the Financial Investment Policy.

The performance of the Investment portfolio excluding cash deposits provided an annualised return of 2.97% for the year to date as at 31 August 2019, 1.15% above the reportable benchmark (BBSW Bank Bill Index). Interest returns remain consistently above the benchmark.

Borrowings:

Council has entered into a principal and fixed loan of \$9.5 million.

The 2019/20 budgeted returns on investments is estimated to be \$1,500,000.00. This is significantly less than previous returns due to the declining cash reserve balances and continued low interest rates. Any surplus funds generated in excess of adopted estimates will be transferred to Council's internally restricted reserves.

Investments and Loan borrowings funding comply with Council's Financial Management Policy.

## 17. GF04: Review of Ward Boundaries

Under section 211 of the *Local Government Act 1993*, councils which are divided into Wards are required to keep those Ward boundaries under review to ensure that a difference in elector numbers of no greater than 10% exists between Wards. ## 18. GF05: Local Government Rating System Review - Draft Submission

Report of Jenny Gleeson, Manager Integrated Planning and Special Projects The NSW Minister for Local Government released the following reports on 21 June 2019, prepared by the Independent Pricing and Regulatory Tribunal (IPART), as part of the local government reform process that commenced back in 2011:

a) Review of the Local Government Rating System (Rating System Review);

b) Review of Reporting and Compliance Burdens on Local Government; and

c) Review of Local Government Compliance and Enforcement.

The Office of Local Government (OLG) is seeking feedback on IPART's recommendations. Council at its meeting of 22 July 2019 (Min. No. 191) resolved to prepare submissions responding to each review.

This report presents the draft submission in response of the Rating System Review (Attachment 1) for endorsement prior to lodging the submission by 13 September 2019. The draft submission has been informed by commissioned independent economic analysis.

In 2018/19, Council revenue from rates and annual charges comprised 44% of its general income (\$58.8M). The draft submission has been prepared in-house. To inform its submission, independent advice was commissioned at a cost of \$37,000. There are no other direct financial impacts to Council as a result of this submission. It is noted however, that should the NSW Government resolve to implement some or all IPART's recommendations there may be an impact to both Council and its ratepayers. Until such time as the Capital Improved Value (CIV) methodology is known and rating categories and minimum rates are confirmed, detailed modelling cannot occur to give an indication of the impacts (positive and negative).
