Report of Manager Traffic and Transport Operations, Michaela Kemp Attached is a list of projects given approval under delegated authority to the Traffic & Transport Operations Manager. Approval was given subject to concurrence of Roads and Maritime Services, the NSW Police and the local State Members. **Recommending:**

Ms Marchandeau stated there was an error on Page 23 of the Traffic Agenda, in relation to Resident Parking, Reference No. 19-075. The Electorate should read, 'North Shore Electorate'.

53. (5.3) Standing Item - Military Road B-Line

Report of Traffic & Transport Operations Manager, Michaela Kemp

At the Traffic Committee meeting on 3 May 2019, it was agreed to add a standing item for each future traffic committee agenda with regard to B-Line, including matters concerning off-set parking arrangements due to parking losses along Military Road, and general traffic and parking matters that arise.

The table overleaf outlines the status of current traffic and parking matters relating to B-Line.

Mr Short addressed the Committee stating that he is concerned about the lack of Police enforcement, pedestrian safety and the local members not speaking out in support of the traffic lights on Military Road.

Hampden Street Bus Stop

Councillor Keen stated that she will forward the correspondence sent to her from concerned residents in regard to reinstating the Hampden Street Bus Stop to the Local Member and the Mayor.

Ms Janakis addressed the Committee and stated that she is concerned that the closure of Young Street will affect her business, causing vehicular congestion in the carpark and will deter people from coming into Neutral Bay.

Council's Director Engineering and Property Services stated that a letter has been forwarded to RMS regarding the closure and Council is awaiting their approval.

The trial is for a temporary closure of Young Street between Military Road and Grosvenor Lane for a period of 3 months at the beginning of 2020. Once the trial period is complete a report will be brought back to Council. Council will also encourage people to give feedback on the closure.

56. (4.3) Review of Trailer Parking Restrictions

Report of Traffic & Transport Operations Manager, Michaela Kemp

At its meeting on 22 March 2019 the Traffic Committee considered a proposal to introduce "No Parking - Motor Vehicles Excepted" in existing unrestricted parking zones for an initial period of 3 months to address ongoing concerns about trailer parking in the following streets:

- Montpelier Street, Neutral Bay
- Fifth Avenue and Montague Street, Cremorne
- Brothers Avenue, Tunks Park, Cammeray

The Traffic Committee recommended, and it was subsequently resolved by Council at its meeting on 29 April 2019 (Min. 115):

THAT Council implement "No Parking – Motor Vehicles Excepted" in the existing unrestricted parking zones on Montpelier Street, Fifth Avenue, Montague Street and Brothers Avenue (excluding the existing "Vehicles with Trailer Only" spaces) and the matter be reviewed in 3 months with a subsequent report to be provided to the Traffic Committee. (4.6)

In addition, at the Traffic Committee meeting on 14 June 2019 it was recommended and subsequently resolved by Council at its meeting on 24 June 2019 (Min. 179):

1. THAT Council restrict the three-month trial of No Parking Motor Vehicles Excepted previously proposed for Montague Avenue and Fifth Avenue to only the northern side of Fifth Avenue, between Brothers Memorial Park and Ellalong Road, and a further report be submitted to the Committee.

2. THAT Council advise the Willoughby Bay Precinct and residents of this resolution. The parking restrictions were installed on 8 July 2019 (Fifth Avenue and Brothers Avenue) and 10 July 2019 (Montpelier Street) following community notification. Parking conditions were monitored during the initial review period and community feedback invited through Council's Have Your Say webpage until 11 August 2019.

This report outlines the outcomes of the community consultation and review of the parking conditions during the initial review period.

59. <u>15 Minute Free Parking Outside North Sydney CBD Post Office</u>

Councillor Gibson stated that she had a request from a local resident for a 15-minute Free Parking outside the Post Office in the North Sydney CBD, after he received a parking ticket whilst in the store.

A Motion was moved by Councillor Gibson and seconded by Ms Marchandeau,

1. THAT Council prepare a report for the next Traffic Committee meeting regarding the feasibility of putting 15 minute free parking near the CBD post office, whilst considering where the parking spaces could be located as well as the number of parking spaces.

Voting was unanimous.

Resolved to Recommend:

1. THAT Council prepare a report for the next Traffic Committee regarding the feasibility of putting 15 minute free parking near the CBD post office, whilst considering where the parking spaces could be located as well as the number of parking spaces.

60. <u>Military Road Footpath Works</u>

Councillor Gibson stated the Pedestrian Council has queried when the Military Road Footpath works will be completed.

It was stated by the Director Engineering and Property Services that the footpath works are being carried out by Council and are being done at night. It is a slow process due to machinery that is being used, some of the machinery is noisy which makes it hard to manage and it can only be used at certain times of night. The footpath can't be closed during the day as businesses need the paths open.

We have noted the residents' concerns in Cremorne and Council's Director Engineering and Property Services will have signage erected to inform people that Council is working to have these works completed as soon as possible.

61. <u>'No Through Road' signage – Corner John Street & Dumbarton</u>

Councillor Gibson stated that the residents in John Street, McMahons Point have asked for a 'No Through Road' sign on the corner of John Street and Dumbarton Street as they get a lot of traffic coming down John Street not knowing that it is a dead end.

Council's Manager Traffic & Transport Operations will have a 'No Through Road' sign erected on the current poles at the top of John Street.

62. <u>Bannerman Street Speed Cushions</u>

David Whitehouse, Bennett Street Precinct addressed the meeting and asked when the speed cushions will be installed in Bannerman Street.

Council's Manager Traffic and Transport Operations stated that the speed cushions had been ordered and that she will follow up on the progress.

63. <u>Motorbikes on Pedestrian Overpass</u>

Councillor Keen stated that she was on the Ridge Street pedestrian overpass and a food delivery motorbike rode over the bridge.

Council's Director Engineering and Property Services will erect signage on the existing bollard on the Ridge Street pedestrian overpass stating 'No Motorbikes'.

64. Intersection of Miller Street and Pacific Highway

Councillor Keen has received the following query from resident Tom Daley:

If a car is travelling South Bound on Miller Street and turning left onto Pacific Highway, they will stop at the traffic lights and wait for the red arrow to be removed. The pedestrian traffic will be given the green walking signal and when the light starts flashing red, the cars turning from Miller Street onto Pacific Highway will have the red arrow removed and they will start to go. There is a blind spot as the entrance to the train station obstructs the view and cars can increase speed around the corner, yet people are still entering onto the road as the pedestrian signal is no longer green and has just started to be flashing red. I have observed several close encounters where cars have almost hit pedestrians and my brother witnessed someone being hit by a car at this spot one evening about 3 months ago. Possible solution: the timing of the light signals to be changed.

527th TRAFFIC COMMITTEE – 6/09/19

Council's Manager Traffic and Transport Operations will forward the resident's query regarding the intersection of Miller Street and Pacific Highway onto the RMS.

65. James Milson Village - Slipway

Councillor Keen stated that the diggers and trucks from Ausgrid are taking up all the parking spaces in the slipway outside James Milson Village, therefore nobody can get access across to James Milson Village.

Council's Manager Traffic and Transport Operations will speak to Ausgrid regarding keeping some parking spaces available.

66. Parking for Tresillian

Ms Marchandeau asked if it was possible to have parking for Tresillian users who have to park there for 3 hours.

Council's Manager Traffic and Transport Operations stated that there is unrestricted parking at the Tresillian end of Shirley Road and that Council conducted a parking survey 6 months ago. In the survey residents stated they preferred more restricted parking. There are 134 unrestricted spaces on Shirley Road and Council has recommended to change 99 of them to either 2 hour or 4 hour parking.

Council will examine the situation and report back to the next Traffic Committee meeting.

67. <u>Spofforth Street/Rangers Road Intersection</u>

Councillor Keen asked if the proposed upgrades currently in concept design on Spofforth Street at the Rangers Road intersection goes all the way down to Florence Street, and the two bus stops be moved down the road and therefore would be more parking down near the shops.

Council's Manager Traffic and Transport Operations stated that it goes down as far as Reginald Street and not as far as Florence Street but could be included if it supports parking offsets.

Councillor Gibson asked that a copy of the resolution from the Mosman Council meeting be brought to the next Traffic Committee meeting.



In streets where parking restrictions have changed there are often flow on-effects to surrounding streets. As a result, some areas have not been reviewed for many years while others have undergone multiple reviews in a shorter period. The staff time to conduct surveys ranges between approximately 20 hours for a single street or up to 60 hours for an area. Following the adoption of the Local Area Traffic Management Schemes, Council will now be undertaking regular periodic reviews of the parking restrictions on an area-wide basis. This includes undertaking appropriate community consultation. To ensure each area is adequately addressed in a timely, cost-effective, and productive way, this approach will start with the areas experiencing the greatest parking pressures, and those that have not undergone recent reviews.
