The Traffic Committee through Traffic Delegated Authority (TDA 19/075) dated 5 June 2019 considered the survey results of a community consultation for Resident Parking Area 15 - Wollstonecraft. The following recommendations were made, received no objection from the Traffic Committee members, and were subsequently approved under delegation to the Traffic Engineer:

Council has received a new CTMP prepared by Varga Traffic Planning Pty Ltd, dated 17 February 2020 for the approved development at 390-394 Military Road, Cremorne (Development Consent 142/19) proposing to use truck and dog trailers instead of medium rigid vehicles. The CTMP is accompanied by a report by K D Cowell & Associates (KDCA) dated 20 December 2019, titled "Spoil Removal at 89 Parraween Street, Cremorne and Selection of Suitable Spoil Removal Vehicle".

The proposed development involves the demolition of the existing buildings on the site and the construction of a new mixed-use development, with a single-level basement

car parking area. The site will be served by a new single entry/exit driveway located towards the western end of the Parraween Street site frontage.

Condition B2 of the development consent 149/19 states:

Construction Management Program – Local Traffic Committee Approval

B2. Prior to issue of any Construction Certificate, a Construction and Traffic Management Plan must be prepared.

The applicant's Construction Traffic Management Plan is discussed in the report overleaf.

Recommending:

- a) **THAT** the proposed use of Truck and Dog trailers for 390-394 Military Road, Cremorne is not approved due to the following concerns:

- Mr Short suggested Council install a puffin crossing at two intersections in Cremorne.
- Mr Thevenin stated that red light cameras combined with speed enforcement cameras are more effective than red light cameras alone and suggested one was needed on Spofforth Street off Military Road, Cremorne.

- It was stated that the Pedestrian Crossing Audit was excellent.
- The Mayoral Minute on Pedestrian Safety went to the Council meeting of 24 February 2020.
- look at pedestrian crossings at schools and prioritise the upgrade of crossings at Clark Road near Anderson Park and Ben Boyd Road outside Neutral Bay Public School.

GENERAL BUSINESS

27. (7.1) Boat and Trailer Parking in Vernon Street, Cammeray

Councillor Gibson stated that a resident contacted her regarding trailers being parked in Vernon Street, Cammeray and suggested Council erect "No Parking - Motor Vehicles Accepted" signs.

Council's Manager, Traffic and Transport Operations stated that Council will develop a policy of how they can roll out restrictions and that a report will be prepared for the next Council meeting in April.

A Motion was moved by Councillor Gibson and seconded by Ms Marchandeau,

1. THAT Council acknowledge the correspondence from Ms Purtell, a resident of Cammeray, concerning the danger of parked boats and trailers on Vernon Street, Cammeray and note that a policy is being prepared as well as a report that be presented to a Council meeting. Council will trial the 'No Parking Motor Vehicles Excepted' signs in Vernon Street as suggested.

2. THAT Council undertake a survey to residents of Vernon Street for a trial of 'No Parking Motor Vehicles Excepted' and that it be reported back to Council as soon as possible.

28. 15 Minute Parking in Princes Street, McMahons Point

Councillor Gibson stated that the owner of Delicardo Foods and Wines, McMahons Point had contacted her wanting to know if Council had introduced 15-minute parking in Princes Street, McMahons Point.

Council's Manager Traffic and Transport Operations stated that there has always been 30-minute parking in Princes Street, McMahons Point and no recent changes have been made. Council will check to see if there are signs that Council aren't aware of that have been erected without Council's authority.

29. Intersection of Bay Road, Pacific Highway and Browns Lane, North Sydney

Councillor Gibson stated that a resident has stated that they would like Council to consider the dangerous and accident-prone intersection at Bay Road, Pacific Highway and Browns Lane, North Sydney. It was stated that there are two sets of lights close together and they are not co-ordinated. They have asked if the intersection at Bay Road, Pacific Highway be a substantial roundabout instead of lights?

It was stated that it wasn't feasible for a roundabout to be placed at the intersection of Bay Road, Pacific Highway and Browns Lane, North Sydney.

30. Traffic Problems 'Keep Clear' sign painted onto Bay Road in front of Browns Lane

A resident stated that people have trouble accessing and exiting Browns Lane by car without difficulty and could a 'Keep Clear' sign be painted on Bay Road in front of Browns Lane?

It was stated by Sergeant Edwards that they are trying to stay away from 'Keep Clear' signs.

Councillor Gibson stated that Council will keep an eye on the Lane.

Council's Director Engineering and Property Services stated that the 10km/h Shared Zone will be identified in the new Masterplan that will be submitted to the Council meeting of 23 March 2020 and he will see if Browns Lane is included in the Masterplan.

31. Additional Crosswalks for North Sydney

A resident wrote to Council suggesting that Council put extra crossings at the corner of Hazelbank Road and Morton Streets or Morton Street and Rocklands Road and Rocklands Road and Gillies Street.

Council's Manager Traffic and Transport Operations stated that Council has put in a blackspot submission for Hazelbank Road and Morton Street, North Sydney. Morton and Rocklands Road, North Sydney is in the LATM action plan and Rocklands and Gillies Streets, North Sydney are also in the LATM action plan.

32. Education Lane, Cremorne

It was stated by Ms Marchandeau representing Felicity Wilson, MP for North Shore that a resident has said that a 'No Stopping' sign was put in Education Lane, Cremorne erroneously by Council. It was asked if Council's Traffic and Transport Engineer, Mr Iman Mohammadi could introduce himself and make an apology for the mistake.

33. Pedestrian Crossing Around All Schools

Councillor Gibson has requested a list of pedestrian crossing around all schools including Kurraba Road and Ben Boyd Road in priority order, and that the Clarke Road pedestrian crossing be made high priority.




