# 8.11. 15mins Free Parking Trial - Parraween Street Cremorne - Outcomes Report

#### **PURPOSE:**

The purpose of this report is to update Council on the outcomes of the 15-minute free parking trial in Parraween Street, Cremorne and the results of the community survey that was undertaken.

#### **EXECUTIVE SUMMARY:**

At its meeting on 26 August 2019, Council resolved to conduct a 12-month trial of 15-minute free parking in Parraween Street, Cremorne (EPS02, Min. No.238). The trial comprised 116 metered spaces in Parraween Street, Cremorne.

Further to the resolution of Council to trial 15minute "Free Parking" in Parraween Street, Council also resolved at its meeting on 21 March 2021, Mayoral Minute (Min. No. 8.2) to defer the trialing of 15-minute free parking at its entire network of 443 parking meters until the trial in Cremorne is complete and the new contract for On-Street Parking Management is awarded.

This report provides Council with detail information on the outcomes of the trial, including the impacts on parking utilisation in Parraween Street, revenue impacts and the results of the community survey that was undertaken during the trial.

The report recommends that Council continues to apply the "15-minute free parking" to the 116 x metered bays in Parraween Street, Cremorne only and that this initiative is not applied to Councils entire Parking Meter network for another 2 years to ascertain if the network can recover to pre pandemic utilisation levels.

The report also outlines the impacts that the introduction of "30minute" free parking would have in Parraween Street if that initiative was to be introduced.

#### FINANCIAL IMPLICATIONS:

As a direct result of the COVID-19 Pandemic, Council's overall parking meter utilisation and accompanying revenue over the last three (3) financial years is down by between 30-35% compared to pre COVID –19 financial years.

For example, in 2018/19 Councils total Parking Meter Revenue for the year was \$9,786,143. In 2019/20 this reduced to \$8,337,196 and again reduced to \$7,860,000 in 2020/21 as a direct result of the impact of COVID 19.

The stay at home and work from home Public Health Orders have dramatically reduced the number of people who come and work and or visit North Sydney and its Village Centres. Workers and visitors coming to North Sydney are the single biggest users of the Council's Parking Meter network. Over 85% of the Parking Meter network is utilised on a daily basis by workers and visitors to the LGA.

This financial year's Parking Meter Revenue Forecast is \$6,250,000.

The cost to Council in Revenue foregone as a result of applying 15minute free parking across the entire network of Council's 443 parking meters (2770 metered spaces) is estimated on Pre COVID figures as \$211,303 per annum or \$17,608 a month.

The actual cost to Council in Revenue foregone as a result of applying 15minute free parking to the 116 x metered spaces in Parraween Street since it was introduced on 17 August 2020 is approximately \$130 a month. For the same period – Pre COVID the revenue forgone would have been \$1,779.60 per annum or \$148.30 a month based on historical data that Council has for these 116 x metered spaces.

**Note:** These monetary figures for revenue foregone only include Parking Meter revenue and not any potential PINs (Parking Infringement Notices) that would have been issued as a result of overstays. Parking Infringement Revenue foregone is not included in any of these revenue figures.

# **RECOMMENDATION:**

**1. THAT** Council continues to apply the "15-minute free parking" to the 116 x metered bays in Parraween Street, Cremorne only.

**2.THAT** due to the impacts of COVID-19 on Council's Parking Meter utilisation and accompanying revenue over the last 3 years, the proposed trial of "15minute Free Parking" across the rest of Councils Parking Meter Network be deferred for a minimum of 2 years to assess whether the network can recover to pre pandemic utilisation levels.

**3. THAT** Council notes in the recent Expression of Interest (EOI) for Council's next generation "On Street Parking Management System" and future contract, the ability to have "15-minute free parking" was built into the Project Brief as a key deliverable.

#### BACKGROUND

At its meeting on 26 August 2019, Council resolved to conduct a 12-month trial of 15-minute free parking in Parraween Street, Cremorne (EPS02, Min. No.238). To facilitate this trial under the current Parking Meter Contract, sensors have been installed in all metered parking bays in Parraween Street and the software and systems were upgraded for the 15-minute free parking. Council at the same time also commenced a survey to facilitate feedback about the trial. The trial comprised 116 x metered spaces in Parraween Street, Cremorne.

Further to the resolution of Council to trial 15minute "Free Parking" in Parraween Street, Council also resolved at its meeting on 21 March 2021, Mayoral Minute (Min. No. 8.2): the following:

Recommending:

- **1. THAT** Council defers the trialing of 15-minute free parking at its 443 parking meters until:
  - a) The 15-minute free parking trial in Cremorne is completed; and
  - b) the new contract for On-Street Parking Management is awarded.
- **2. THAT** Council notes the new On-Street Parking Management Contract will be going to tender in August 2021 and it will include provisions for the ability to enable 15-minute free parking functionality.

The financial and operational implications of introducing 15minute free parking in Parraween Street was modelled on the same criteria and on street parking environment that operates in other Council areas currently offering free parking. The City of Sydney and Brisbane City Council offer 15-minute free parking in selected locations using ticket and or pay by plate machines. City of Sydney have assigned 15-minute free parking to approximately 10% of their metered spaces in selected village areas only.

It is important to note that as a result of the impact from the COVID-19 Pandemic Crisis and the flow on effect it had on business activities within the North Sydney LGA, the utilisation of Councils parking meter network and accompanying income is down by over 30% compared to Pre-COVID-19 Pandemic levels.

The stay at home and work from home Public Health Orders have dramatically reduced the number of people who come to work and or visit North Sydney and its Village Centres. Workers and visitors coming to North Sydney are the single biggest users of Councils Parking Meter network. Over 85% of the Parking Meter network is utilised on a daily basis by workers and visitors to the LGA.

#### Survey Results

#### Summary 15-minute Free Parking Trial - Survey Results

Council has undertaken a survey on the 15 minute "Free Parking Trial" in Parraween Street Cremorne from 26 August 2020 to 19 December 2021. Council received 46 responses, all of which supported free parking.

In summary:

- 24 supported 15mins Free Parking.
- 22 supported more than 15mins Free Parking which included specific requests as follows:
  - 14 prefer 30mins Free Parking.
  - 1 wants no meters and 2P Free Parking.
  - remaining wanting 20mins or just more free time.

Based on the survey, 48% of responders that support "more than 15 minutes" free parking, 64% of these responders requested "30 minutes free parking".

Council should note that some submissions suggested that the "Free Parking Trial period" be extended to either 20 or even 30minutes "Free Parking"

#### DETAIL

# Changes in Parking Utilisation (Turnover – Capacity Overstays) – as a result of the introduction of "15minute Free Parking" in Parraween Street Cremorne

Parking utilisation data was collected prior to and during the 15-minute free parking trial of the 116 metered bays in Parraween Street, Cremorne. This data was collected outside of school holidays and during fine weather. The data was sourced using two methods.

 Roar Data Pty Ltd – survey data collection consultant was engaged to conduct a total of eight (8) surveys during October and November 2019, November 2020 and November 2021. For each survey, parking utilisation or vehicle occupancy was recorded at 15-minute intervals between 8:00am and 9:00pm on a Thursday and Saturday to cover the following time periods:


AM – 8:30am to 11:00am MIDDAY – 11:00am to 2:00pm PM – 2:00pm to 6:00pm EVENING – 6:00pm to 9:00pm

2. A second set of data was collected internally by a Council officer during weekdays between 8:30am and 5pm. The data was captured once during each allocated time period. A total of 14 surveys of this type were conducted between September and November 2020, and February to November 2021.

The two datasets were combined for a comparative analysis of pre 15minute "Free Parking" period, specifically looking at turnover and revenue, compared to the period during the 15minute "Free Parking" trial.

In addition, to validate the accuracy of the data, payment details were cross-checked with the Parking Management System (PEMS) and Council's resident parking permit records, to determine if parking spaces were legally or illegally occupied.


Council's data collection indicates no change to AM parking occupancy since the trial began mid-August 2020, with occupancy rates remaining within 40 – 50%. Refer to Graph 1.




Graph1. AM Occupancy – Weekdays only

There was a slight reduction in parking occupancy during the MIDDAY time period in September 2020, which remained steady at around 40% to 50% until November 2021. This reduction in occupancy reflects the impacts that COVID-19 was having across the Parking Meter network at the time with the "Stay at home" Public Health Orders. Refer to Graph 2.

# Graph 2. Midday Occupancy – Weekdays & Saturday AM




Similarly, the PM time period indicated a reduction in occupancy rates from over 70% in November 2019 to a low of almost 30% in September 2020. Refer to Graph 3.




Graph 3. PM Occupancy – Weekdays and to Saturday 12.30pm

EVENING occupancy increased from October to November 2019. It should be noted that parking restrictions for the trial area (116 metered spaces), cease from 6pm Monday to Friday, 12.30pm Saturdays and all-day Sundays – so PM (Evening Occupancy) is unaffected by the trial. Refer to 4



#### Graph 4. Evening Occupancy After 6pm – Weekdays & Saturday

The number of overstays/illegally occupied vehicles recorded in the 15 minute "Free Parking" Trial Area is trending upwards between 10-20% when comparing 2019 and 2020 pre-trial data. Since February 2021 there has been quite a significant increase in the number of illegally occupied vehicles, due to the COVID-19 restrictions being relaxed. Refer to Graph 5.




# Graph 5. Overstay Data

This trend suggests that people use this area for parking are taking advantage of the 15minute "Free Parking" and are staying longer (Overstaying). Overstaying reduces turnover and the opportunity for other people to park in the area.


The following graphs outline the Monthly Average for Occupancy and Turnover – BEFORE and AFTER the 15mins Free Parking functionality went live: *Refer to graphs 6.1 and 6.2* 

Comparing the **Occupancy** BEFORE (Graph 6.1) and AFTER (Graph 6.2) indicates occupancy declined 21% per space per month since "15mins Free function" went live. This is due to the impacts of COVID –19 which has seen a reduction in the utilisation of Parking Meters across the entire network by between 30-35% compared to pre-pandemic levels.




Comparing the **Turnover** BEFORE (Graph 6.3) and AFTER (Graph 6.4) indicates slight increase in turnover of 6.2% since "15mins Free function" went live. Indicating a slight increase in people who utilise the spaces for a "short term".

Graph 6.4 - TURNOVER - AFTER 15mins Free Parking functionality was released at 116 spaces

Finding - Average turnover - 4.49 per space per month - slight increase 6.2% comparing before the "15mins Free" release



Graphs 6.3 and 6.4 show the comparative data for before the" free" 15minute parking trial was introduced and the results during the trial. The results show a small increase in turnover by 6.2% per car per space. This small increase in "short term" turnover is mostly due to the impacts of COVID-19 on the utilisation of Council's Parking Meters and secondly the number of" Overstays" increasing (10-20% increase) reducing "short term" parking availability on the street.

# Revenue Foregone – as a result of the introduction of 15minute "Free Parking" in Parraween Street Cremorne

The following tables have been prepared to outline the impacts that the introduction of 15minute and 30minute "Free Parking" would have on Council's Parking Meter Revenue overall and also specifically at the 14 parking meters servicing 116-meter spaces in Parraween Street.

These figures are based on "Pre COVID-19 revenue figures for Table 1. All Council's 443 parking meters (2770 metered spaces) and Table 2. Parraween Street – 14 parking meters (116 metered spaces).

# Summary of Trial Data collected

As a result of the introduction of the "15mins Free Parking" Trial, the occupancy in the 116 x metered spaces has actually declined by 21% and the turnover has increased only slightly by 6.2% when comparing the PRE "15mins Free Parking" occupancy and turnover data.

The reduction in occupancy can be directly attributed to the impacts that COVID-19 has had on the utilisation of Council's Parking Meter network which is down by 30-35%. In addition, there has been a corresponding increase in illegal/overstays in the trial area as indicated in Graphs 6.3 and 6.4. This trending upward in "Overstay behaviour" suggests that when people do park in this area, they are taking advantage of the 15minute "Free Parking" and staying longer than 15minutes.

What is also clear from these results is that if Council considers extending the "free parking" period from 15 to 30 minutes anywhere across its network of Parking Meters, it will have a detrimental effect on turnover and "Overstay behaviour". People would take advantage of the "Free" parking period and "Overstay". Reduced turnover and increasing "Overstay behaviour" denies those people who utilise the 15minute "Free Parking" to buy a coffee, pick up takeaway and the like, driving them away to make their purchases elsewhere which would impact upon local businesses.

Since the trial began in August 2020, the actual cost to Council in Revenue foregone as a result of applying "15minute free parking" to the 116 x metered spaces in Parraween Street is

approximately \$130 a month. For the same period – Pre COVID, the revenue forgone would have been \$1,779.60 per annum or \$148.30 a month based on historical data that Council has for these 116 x metered spaces.

The estimate of revenue foregone if 15minute "free Parking" was increased to 30minute Free Parking for the 116 x spaces in Parraween St is \$848 per month, or \$10,000 per annum with an accompanying increase in potential "Overstays" or simply a reduction in available parking spaces in the street.

These figures maybe relatively small for this stand-alone area, but they are significant in that they represent what a broader effect on turnover (Parking availability) and revenue would be if 15 minute "Free Parking" is applied across all of Council's 443 parking meters (2770 metered spaces).

It is clear from these results that the "15mins free parking" achieves some of the desired effect on parking utilisation and turnover with a consequence being higher incidences of short term "Overstays" (between 10-20% increase) being reported. The results do clearly indicate that an increase to 30mins "Free Parking" would have the opposite effect on parking utilisation and turnover in Parraween Street and also across the LGA and should not be considered.

# CONCLUSION

Overall, there was strong support to retain the "15minute Free Parking" in the 116 x metered spaces in Parraween Street, Cremorne and therefore it is recommended in this report that the "15minute Free Parking" remain in place.

The overall parking turnover and capacity is only marginally impacted in this section of Parraween Street as a result of the introduction of "15minute Free Parking" of approx. 6.2% increase in turnover. The cost to Council in revenue foregone as a total percentage of the overall parking meter revenue is also very small – less than 1% or \$1,779.60 per annum.

The introduction of 15mins "free" parking in this area (116 metered spaces) has also resulted in an increase in overstays (10-20% increase) compared to pre-trial data.

It is not recommended to increase the "Free Parking" to 30minutes in this section of Parraween Street or across the LGA because of the demonstrated impacts on Parking turnover, availability and overstaying as well as revenue impacts. Overall turnover and parking capacity for all street parking users in this section of Parraween Street would be significantly impacted if "30minute Free Parking" was introduced. It can be accurately predicted that "Overstays" would increase to 50% or more and the revenue forgone to Council would be in the order of \$10,178.52 per annum.

To address the Mayoral Minute (Min. No. 8.2) and resolution of Council of 21 March 2021, this report is also recommending that due to the impacts of COVID-19 on Council's Parking Meter utilisation over the last 3 years, the application of 15minute "Free Parking" across

selected parts or even the entire parking meter network of Council be deferred for a minimum of two (2) years. This two-year period would allow Council enough time to assess accurately whether the network can recover to pre pandemic utilisation levels or whether the workplace and business environment has changed permanently in the North Sydney LGA because of the impacts of COVID-19.

Council is also to note that in the recent Expression of Interest (EOI) for Council's next generation "On Street Parking Management System" and future contract, the ability to have "15-minute free parking" was built into the Project Brief and Proposed Systems criteria

#### Parraween Street, Cremorne - 15-minutes free parking meter trial

Submissions received during public exhibition period between 26 August 2020 – 19 December 2021

**Outcome of survey** - Note all responders accepted that they read and understood Council's Privacy Statement. Only one responder requested that their details be withheld. A copy of the Privacy Statement has been included at end of this survey summary document.

46 submissions were received and all supported Free Parking. In summary:

- 1. 24 supported 15mins Free Parking.
- 2. 22 supported more than 15mins Free Parking. (14 prefer 30mins free; 1 wants no meters & 2P FREE and remaining want 20mins or just more free time)
